These include:

- informing the families and parents about the importance of education and motivating them to bestow proper education for their female children particularly.
- Inculcating belief that whether you are addressing healthcare, poverty, populatin control, unemployment or human rights there's no better place to start than in the corridors of Education.

# Projects in India

## Orphanage Support Programme:

Child Help Foundation provides shelter, food, clothing and education to the orphan children and also covers their medical expenses. Child Help Foundation gives a holistic approach towards the underprivileged children through 3 orphanages. Two such orphanages namely Vision in Social Arena (Anmol Home) and Shri Rajendra Honeycomb Charitable Children's Trust (Bal Ashram) are both located in Thane District. Anmol Home shelters street children where in 40 school going children are living under healthy circumstances currently. Where as, Bal Ashram comprises of 50 school going children. The third orphanage Karunalaya (Sharon Ministry of Tribals) located in Bengaluru takes care of 42 children.

Yadav is a very disciplined boy who does not talk much and is a very keen observer. He is ready to help anyone who needs help. He also takes care of his younger brother in the orphanage and has got an elder brother too. He is a bright student. He secured 78% in his last test and now wants to achieve 80% in the next test. He is also good in sports and he represented his school in a football team. His favorite subjects are English, Geography and History He lost his parents in a very young age.

### **Educational Support Program:**

Through this program we support the educational responsibilities of all rural and underprivileged children who are not economically capable of buying an education. With the absence of proper educators to learn from and guidelines to follow, the children in the rural areas are often misguided. Their

chance to grow as individuals has been compromised on due to the shortage of real education at an affordable price.

We fulfill their needs by enhancing their computer skills, providing English educators, toys and comics for recreational purposes, a well

suited library, good clothes, educational books, school benches and other stationery items like pencil sets and school bags. Because we believe economic disparities should never stand as an obstacle between a student and his education.

Child Help Foundation is currently proposing a national level programme that will train the rural underprivileged adolescent youth in English Proficiency, Basic Computer Education and Soft Skills for enhancing their prospects of employment in the fast expanding retail, hospitality, KPO & other industries.

The program in Phase I will cover 6 states & reach up 15 states in phase II.

These programs will help realize the potential of the youth & keep them rooted to their villages thus helping the rural economy to gain foothold.

These projects will support more than 100 grassroots initiatives working for the education of very poor and underprivileged children in various states of country like Jharkhand, Uttar Pradesh, Uttaranchal, West Bengal, Andhra Pradesh, Tamil Nadu, Karnataka, Kerala, Maharashtra, Gujarat, Rajasthan, Haryana, Madhya Pradesh, and Chhattisgarh etc.
