Calamity Relief Support Program Chennai Relief Support Program 2015



Severe Rains in Chennai disrupted normal life, heavy rains lashed parts of Tamil Nadu, and neighboring Puducherry, disrupting transport movement and left the city submerged and airport flooded with rain water.

The death toll in rain-related incidents touched 188 in city of Chennai

Heavy rain caused major flood threat over many areas in Chennai. Around 29,000 cusecs of water has been released into River Adyar. This resulted in flooding in the slums of Adyar, Saidapet, and Kotturpuram. Around 3600 people were rescued using boats. Many residents of the region have been left homeless.

Condition in slum areas became worst. Underprivileged community is affected badly due to these rains. People had no food to eat as all the sources were blocked.



Child Help Foundation reached the affected underprivileged community in this calamity.

Child Help Foundation has started relief work with support of local volunteers in affected slums in Chennai city.

Slums covered by CHF: Achipet, Byasarpadi, Gandhipuram

Number of household supported: Approximately 3000

Child Help Foundation implements a well thought plan of spreading awareness in our targeted communities. It starts from the young ones at schools, whose brains are most receptive. They are tuned and guided to induce and inculcate the new ideas in their homes, villages and localities. Once the seeds of ideas are sowed in the ground of a family and community, it becomes important to water them for proper germination and grow into a new plant or a tree.

CHF conducted parent teacher meetings and reiterated the importance of the new ideas and way of living. The same strategy is employed in our cleanliness drives too.

One such meeting was held at Zilla Parishad School, Rajavali in the month of November, 2015.



Objective of Parents - Teachers Meet:

1. Encourage parents to send their children to school.
2. Ensure that their child regularly gives 2 hours to do homework.
3. Monitor their children's progress.



WISH TREE event was conducted with the help and support of EVEREST group on 27th of August, 2015 at MIRACLE SCHOOL. Top executives from the corporate were present at the project sight and distributed gifts like Carrom Boards, Pencil Boxes, Footballs, Barbie Dolls, Kitchen Sets, Lunch Boxes, Teddy Bears, Bats, Dictionaries etc.



Child Help Foundation project team conducted a base line survey in two slums.

Slum Name: 1. Sambhaji Nagar 2. Babli Pada

Location: Dahisar, Mumbai

Methodology: Base line Survey, Personal interaction, filling up of survey form

Total No. Of Samples collected: 52+37 = 89

Type of Sample collection: Random Sampling

Important observation and survey finding

1. Average no. of Family Members in a house hold : In both the slum it was identified that the total No of house hold is between 4 to 5
2. Major Community : The residents mostly identified to be migrants coming from Uttar Pradesh, Rajasthan, Karnataka, Tamil Nadu and also from other parts of Maharashtra
3. Major Caste: The caste identified in both the slums were OBS, ST, SC
4. Average Monthly Income : In Sambhaji Nagar the average monthly income of household identified to be between 6000 to 10,000 and in Babli pada between 3000 to 10000
5. Ration Card : The residents in both the slums use Orange ration card which is used by
6. Average No. of children in each household: In each house hold identified two to three children in both the slums
7. Major health issue identified amongst adults : In Sambhaji Nagar there was no major health issues identified, but in Babli pada few health issues identified such as - Tuberculosis case, Diabetes, Blood pressure (Hyper tension).
8. Addiction: In both the slums substance abuse prevails such as - Alcoholism and tobacco use, smoking
9. Children going for private tuition: In a Sambhaji Nagar out of the respondents family 48 children goes for private tuition and in babli pada 43 children goes for private tuition.
10. No. of working women: Out of the respondents family in Sambhaji nagar 32 women identified as working women and 4 women identified as working women in Babli pada and rest are house wife. Out of the total 36 working women majority of them identified doing small business from home such as tailoring work and papad making, from, few work as maid servant, few go for service in private enterprises.
11. Major community requirement: During the base line survey the major community need which was identified were - Vocational training, Education support for their children as most of these children are going for private tuition and tuition fee is high which the parents cannot afford and other need identified was basic health awareness on public health issues and epidemics.



Recommendations:

It is highly recommended on the base of data analysis that establishing a community development centre in the targeted slum will be a productive intervention which will be based on self sustainable model and the impact of the programme over a period of time can be measureable by establishing a stringent monitoring system.

Following capacity building activities recommended:

Vocational Training : Most of the community women are housewife and during the survey the community women showed interest for supporting their family income by working from home so it's recommended that conducting periodic vocational training for these women would be useful.

Few vocational training recommended is - Tailoring, Beauty parlour, papad making, candle making, diya making, varli painting, agarbatti making,

Self help group and Micro Finance: Formation of Self help groups will be a self sustainable model for women trained in vocational training and support these women to get funds for starting small scale business from micro finance enterprises.

Socially useful productive work (SUPW): it's a volunteer ship programme where Volunteer can give certain hours for teaching the children who cannot afford private tuition the volunteer can teach Mathematics, Science, English

Computer learning centre: The community development centre can also be used as computer learning centre for teaching the underprivileged children from slums.

Advocacy campaign: Under this following activities can be done:

- Life skill education for adolescent girls
- Health awareness
- Career guidance for youth
- Leadership development training for youth
- Health Camps
- Street plays
- Group and individual counselling
- Play group and toy bank

Child Help Foundation aspires to maximise the project impact by bringing significant improvement in standards of health, education and over all wellbeing of underprivileged children from targeted communities.

Child Help Foundation aspires to be the largest “Enabling and Implementing charity organisation of the country” in the social development sector. CHF strategies to meet its goal by increasing reach, visibility and effectiveness of the services delivered by it and its implementing partners.

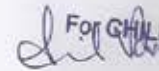
