Committed to the fulfilment of Child Rights as promised by the Indian Constitution and United Nations Convention on the Rights of the Child (UNCRC), CHF's principal purpose is to empower the disadvantaged holistically with some of our initiatives like Emergency Medical Support, Education, Clean Water, and Sanitation, Gender Equality, Zero Hunger and Humanitarian Relief.

CHF also works largely in bringing about a balance in society by taking care of stray animals under our Life on Land initiative and Beach Clean Up activities under our Life Below Water initiative.

Today, CHF is nationally recognized for its efforts to uplift the underprivileged in society. Our response is multi-sectoral based on reliable expertise and extensive groundwork. We have implemented multiple grassroots-level initiatives all over the country in 21 states.

Amongst many others, CHF has won various awards in 2019-20: The ET NOW - Rise with India Award for the Best NGO in Healthcare, Best NGO in Education for Girl Child, Best NGO for Cancer Prevention, Award for Dedication and Commitment from Tata Memorial Hospital, and the Dadasaheb Phalke International Film Festival Award for Benevolent Efforts in Social Welfare. In August 2021, CHF received three awards at the 7th Edition of National Awards. These awards were received for Best Covid -19 NGO for Community, Best Healthcare NGO of the Year, and Best NGO for Education for Girl Child.

We have offices in 12 cities including Mumbai, Thane, Pune, Delhi, Kolkata, Bhubaneswar, Hyderabad, Kochi, Bengaluru, Chennai, Gurugram, and Dimapur. We also have an international presence in the United States of America.

VISION: Reaching out to marginalized children in need, empowering them, bringing smiles, and making them future-ready.




Child help Foundation helps fund the treatments of children suffering from life-threatening, non-communicable diseases like Congenital Heart Diseases, Cancer, Organ Transplants, and Preterm Babies, amongst many others. We ensure that these children get the required treatment as soon as possible, and their families get the support they need throughout the treatment.

Prathyush Giri

Prathyush is a 3-year-old boy from Pune. His father, Mr. Khokan Giri is a daily wage labourer and her mother, Mrs. Kavitha Giri is a housewife. Prathyush is their only son and the family consists of three members.

Prathyush was very young when his heart defect was diagnosed by the doctor during medical tests. Since then he has been under medication. He kept suffering from the time of his birth. Currently, he is being treated in Care hospital, Hyderabad. He is suggested to undergo Multiple VSD closure and ASD Closure surgery. The estimated cost of his treatment is Rs. 5,00,000/-.









Piyush Kamat

Piyush Kamat is a 3-year-old boy from Gwalior, Madhya Pradesh. His father, Mr. Madan Kamat, a daily wage labourer, is the sole breadwinner in the family of four. His mother, Mrs. Sarita Kamat, is a homemaker. Piyush has an elder sister, Komal Kamat, who is 14 years old.

Baby Piyush was born during the winter season. His parents noticed that he was having difficulty breathing when they heard wheezing noises from his chest. Worried about their baby's health, they took him to the local doctor. The doctor also raised his concerns and asked them to consult a specialist. The family borrowed money from their neighbours and loved ones to bear Piyush's medical tests cost.

The test results diagnosed him with Congenital Heart Disease and for further treatment, he is now being treated at Paras Hospitals, Gurgaon. The doctors have suggested that he undergo open-heart surgery. The estimated cost of his treatment is Rs. 4, 50,000/-

Baby of Bhagyashree

The baby boy of Bhagyashree was born on 26th November 2021, in the seventh month of pregnancy, as a premature baby. His father, Mr. Siddharth Singh, is regularly unwell and is unemployed. Mrs. Bhagyashree, the baby's mother, worked at a garment factory, as a helper, but lost her job due to the COVID-19 pandemic. The family's only support is the baby's maternal grandmother, who works as a domestic worker and earns just Rs. 2,000/- per month.

Bhagyashree Singh underwent a C-Section while giving birth and is now admitted to another hospital for a week. The infant's grandmother is trying to make ends meet to support her daughter's and her grandson's medical bills by borrowing money from her employer.

The baby of Bhagyashree was born with most of the symptoms of a preterm baby. His body weight is minimal and he suffers from respiratory distress due to immature lungs. The little child has been admitted to Queens Hospital, Thane. Dr. Talib Surve, the doctor-in-charge, has suggested a NICU stay for about 35 days. The baby will continue to require oxygen support, monitoring of his vitals, daily blood check-ups, and NIV support in case of respiratory diseases. The entire treatment will cost Rs. 3,00,000/-.





Baby of Jagruti

The baby of Jagruti is an 8 days old premature baby from Kalwa, Thane. Since her birth, she has been in the Newborn Intensive Care Unit (NICU) in Queens hospital, Thane. Her father, Mr.Shreyans Bhagyawant is a supervisor earning Rs. 8,000/- per month and Mrs.Jagruti is a homemaker. Baby's grandfather, Mr. Vinod Bhagyawant is an auto-rickshaw driver who earns approximately Rs. 10,000/- per month and her grandmother is also a homemaker.

The family is concerned for the baby as she is fighting for her life in the NICU every day. The ongoing treatment costs them Rs. 10,000/- per day. The doctors have advised continuing the ventilator support for 2 months for her to recover. The family was forced to borrow money from their friends and relatives for their lovely daughter's treatment. The estimated cost of the further treatment is Rs 3,00,000/-.

The baby is showing signs of recovery gradually. But the family is now drained of all their savings. In spite of having two bread earners in the family, they are unable to afford her further treatment due to the expensive daily NICU charges.


Satyam Sangekar

Satyam Sangekar is a 3-year-old boy from Nanded, Maharashtra. His father, Mr. Madhukar is a construction labourer and his mother, Mrs. Bhagyashree is a housewife. He is the eldest and has a younger brother Shivam who is 9 months old.

A few months back, Satyam's parents noticed that he had a swollen stomach which did not reduce. Satyam would feel very uneasy due to his swollen stomach and also ate less. His parents consulted a doctor in Nanded where his treatment started. Even after a long treatment, Satyam did not recover.

He was then shifted to Deenanath Mangeshkar Hospital, Pune for his treatment. He is suggested for a liver transplant for his recovery. The estimated cost of his treatment is Rs. 20,00,000/-.







Baby of Jijitha

The baby boy of Mrs. Jijitha A. R. was born on 24th September 2021, in the seventh month of pregnancy, as a premature baby. His father, Mr. Sudeesh E. M. is a fisherman, who barely makes an earning of Rs. 4000/- per month, and her mother is a homemaker. The family consists of five members, as Sudeesh's parents live with the family.

The baby is suffering from Respiratory Distress Syndrome and low birth weight due to prematurity. He also suffers from neonatal sepsis which is a type of blood infection. The doctors at Amrita Institute of Medical Sciences, Kochi, have suggested the baby be kept in the NICU for four weeks. The parents have already spent around Rs. 4,50,000/- for their baby's treatment.

The child's further treatment is estimated to cost Rs. 9,00,000/-. Mr. Sudeesh is trying to make ends meet to be able to raise this amount, but he is unable to do so.

Paras Sakate

Paras Sakate is a 2-year-old boy from Pune, Maharashtra. His father Mr. Hanumant Sakate, a daily wage labourer, is the sole breadwinner in the family of four, with a minimum of Rs. 9,000/- per month. His mother, Mrs. Chakuli is a homemaker. Paras has an elder sister, Anisha Sakate (4yrs). The family lives in a rented house, with a monthly rent of Rs. 4,000/-.

When Paras was six months old, his parents noticed a small lump below his right ear. The lump seemed harmless, so no action was taken against it. Unfortunately, the lump kept growing with time. Paras used to cry a lot but his parents were unable to understand his pain, as he could not speak. When the baby turned two in October 2021, they finally took him to the AiMS Hospital, Pune. Medical tests were done, and Paras was diagnosed with a Multilocular Cystic Lesion, which is a type of slow-growing tumour. As a part of his treatment, he needs to undergo Excision of Large Hamartoma Surgery to extract the tumour. The estimated cost of the surgery is Rs. 4,35,000/-.







Rahul Banoth is a 10-year-old from Marredpally, Secunderabad, Telangana. He is the younger son of Mr. Babu Banoth and Mrs. Padma Banoth. His elder brother Vishal Banoth is 14. Mr. Babu worked as a cable technician with a monthly salary of Rs. 15,000/-. Currently, he is unemployed due to the COVID-19 Pandemic.

In 2018, Rahul began suffering from severe joint pain, and he kept running high fevers. Concerned, his parents took him to a local doctor. Medical tests were done, and the family was shocked after knowing the results. Rahul was diagnosed with B-Cell Acute Lymphoblastic Leukemia. As a part of his treatment, Rahul had to undergo four rounds of chemotherapy, at Rainbow Children's Hospital, Hyderabad, due to which his symptoms subsided for a few months.

During Ganesh Chaturthi 2021, like any other child, Rahul was excited to celebrate Bappa's arrival. He enjoyed the festival thoroughly. Although, on the last day of the celebration, his symptoms resurfaced.

He complained about joint pains and fevers again. The doctor treating him suggested three more rounds of chemotherapy. Unfortunately, chemotherapy is not the ultimate solution for his ailment. He needs to undergo a Bone Marrow Transplant (BMT) urgently. His brother Vishal will be the donor for the same. The estimated cost of the entire treatment including chemotherapy, hospitalization, stem-cell transplant, and medicines is Rs. 14,00,000/-.

Kapil Singh

Kapil Singh is a 10-year-old boy from Mathura, Uttar Pradesh. Mr. Anil Singh (father) works as a daily wage labourer on farms. He earns a minimum income of Rs. 6,000/- to Rs. 7000/- per month, depending on the nature of the work he gets. Kapil's mother Mrs. Savitri is a homemaker. The parents also have an elder daughter Annu (14yrs). They live in a rented house, with a monthly rent of Rs. 4,000/-.

A year ago, the family panicked when Kapil started having stomach aches and threw up blood. One of their relatives recommended them to take the child to the Indraprastha Apollo Hospital, Delhi. Kapil was diagnosed with Congenital Heart Disease and was admitted to the hospital. The family has borrowed Rs. 1,00,000/- from their friends and relatives to meet Kapil's treatment and hospital bills. The doctors have suggested he undergo open-heart surgery. The estimated cost of his surgery is around Rs. 4,00,000/-.

Vitthal Bhosale

Vitthal Bhosale is a 12-year-old boy, suffering from Congenital Heart Disease (CHD). His father Mr. Karan Bhosale and his mother Mrs.Sukanya Bhosale, are daily wage labourers earning up to Rs. 250/- and Rs. 100/- everyday respectively, depending on the nature of work. Vitthal has two siblings, Chetan Bhosale(16) and Renuka Bhosale(17). The family lives in a rented house with a monthly rent of Rs. 2,000/- in Sonpeth, Parbhani District, Maharashtra.

Vitthal was one and a half years old when he started suffering from difficulty in breathing. Concerned, his parents took him to a hospital in Aurangabad. The doctors detected his heart defect and warned the parents that it will prolong. With age, the defect worsened.

As he turned 12, Vitthal's symptoms aggravated. He was taken to AiMS Hospital, Pune. The doctors have suggested him to undergo an Urgent Balloon, Pulmonary, valvuloplasty Heart Procedure. The cost of his treatment is Rs. 2,38,000/-.

Soham Borke

Soham Borke is the 7-year-old son of Mr. Ram Borke and Late Mrs. Renuka Borke. His father is a daily wage plumber, and the only earning member in the family. Soham's mother passed away two years ago due to pneumonia. Since her death, Soham's elder sister Vaishnavi (20) has been looking after the family of four. Soham also has another elder sister, Sandhya (15). The family lives in Latur, Maharashtra.

The Borke family got worried sick when they saw their only son's body develop bluish discoloration when he was only 8-days-old. The doctors diagnosed baby Soham with a heart defect. Since then he has been put on medications. Soham's heart rate increases rapidly if he misses his medicine dosages. When he turned 5, this dosage was increased. However, these medicines are unable to stabilize his condition.

He was taken to the Fabiani and Budhrani Heart Institute, Pune, and the doctors there have advised him to undergo a Fontan Completion Surgery. The estimated cost of the treatment is Rs. 4,00,000/-.



Aamir Zaman

Aamir Zaman, a 16-year-old boy, lives in Kochi, Kerala. His father, Mr. Abdul Jibeesh moved to one of the Middle East countries for work but lost his job there due to COVID-19 lockdown. He has now secured a job that pays him a minimal salary. Aamir's mother, Mrs. Shabana is a homemaker; he has a grandfather who is a retired bank manager, a grandmother (homemaker) and a younger brother, Aahil Zayan (10 yrs).

The family owned a house in Trissur, Kerala, but were forced to leave due to unforeseen financial situations. Currently, they live in a rented house near Indira Gandhi Hospital in the Ernakulam region.

Aamir was suffering from migraine-like headaches that became severe in March 2021. A bump appeared on the back of his neck as well. The family took him to a local doctor. Looking at his condition, the doctor suggested taking Aamir to Indira Gandhi Hospital, Ernakulam, Kerala. The check-up at the hospital diagnosed Aamir with T-Cell Lymphoblastic Leukemia.

The doctors proposed continuous chemotherapy for two years as a part of his treatment. The chemotherapy sessions started in May 2021. The family used their savings for the chemotherapy sessions till now. Unfortunately, their savings have drained. The family is unable to afford further treatment and support their living expenses as well as the younger child's education. The estimated cost of further treatment for Aamir is Rs. 5,00,000/-. Aamir's health will improve only if his treatment continues.





Lakshay Singh

Lakshay Singh is the 6-year-old son of Mr. Nirbhay Singh and Mrs. Poonam Singh. His father is a security guard supervisor with a monthly income of Rs. 16,000/-, and his mother is a homemaker. The family of three lives in Mira Road, Mumbai.

On 4th November 2021, when the entire nation was happily celebrating Diwali, little Lakshay met with a horrible accident that changed his life forever. The boy and his father were playing with firecrackers in their society compound when a spark from the phooljhari (sparkles) lit up an entire bag full of firecrackers, and Lakshay's body caught fire. All his clothes got stuck to his body, causing immense pain to the little boy.

His father and neighbours were horrified by the incident and took him to a local clinic. The doctor saw the severity of the injuries and advised the father to take their son to Family Care Hospital, Mira Road. Here, his wounds were cleaned up but unfortunately, they did not have the equipment to treat Lakshay further. He was then shifted to National Burns Center, Airoli.

The doctors have suggested multiple skin grafting surgeries, out of which two surgeries have been performed successfully. The Singh family borrowed money from relatives and neighbours for Lakshay's treatment. All their savings, including Mr. Nirbhay's Diwali bonus, are utilized completely. A total of Rs. 3,90,200/- is the estimated surgery cost, and his father has no means to raise this huge amount.

Noor

Noor, a 2-year-old girl from Punjab, is the youngest daughter of Mr. Gagandeep Khan, and Mrs. Sompal Kaur. Her father owns a small grocery shop, and her mother is a homemaker. Noor has an elder brother, Alphaz Khan, who is 8 years old.

Noor was born with a heart defect which was diagnosed a few hours after her birth. The heart defect was confirmed with a series of medical tests. Doctors had advised waiting for the surgery as in some cases the defect recovers over time. Unfortunately, in Noor's case, this couldn't happen, and her suffering increased with time.

She was admitted to Paras Hospitals, Gurgaon for her treatment, where she was advised to undergo PDA device closure and Balloon Pulmonary valvuloplasty. The estimated cost of her treatment was Rs. 2,50,000/-.

Her family was needy and approached CHF for financial aid. After necessary verifications, CHF agreed to help Noor and her family to raise the required funds. She was discharged from the hospital on 21st December, after a successful surgery.

Kunal Aher

Kunal Aher is a 10-year-old boy from Nashik, Maharashtra. He hails from an underprivileged family. His father, Mr. Sudam Aher, is a farmer and is the only breadwinner in the family of four. His mother is a homemaker. Kunal has a younger brother as well.

Kunal Aher suffers from Progressive Bilateral Equinovarus Feet Deformity with loss of bladder control. In simpler terms, it is a congenital limb disorder or clubfoot (by birth the child's feet are inward), secondary to a pathology of the spinal cord called Diastematomyelia. Diastematomyelia is a congenital disorder in which a part of the spinal cord is split.

Kunal needed spinal surgery under advanced technology of spinal neuromonitoring along with Bilateral Feet Correction. His parents were finding it difficult to enquire through various hospitals to get it corrected. At last, he was admitted to the Ashoka Medicover Hospital, Nashik. The estimated cost of Kunal's treatment and hospitalization was Rs 5,00,000/-.

CHF helped the Aher family to raise funds for their elder son's treatment. Currently, Kunal is at home after his surgery was performed successfully.

Dheena Dayal

Dheena Dayal is a 13-year-old boy from Idukki, Kerala. His father, Mr. K R Chinna Thampi is a farmer and his mother, Mrs. R Kayalvizhi is a homemaker. He is their only son and the family consists of three members.

After eight months of his birth, Dheena Dayal began to suffer from continuous vomiting. He had lost weight and experienced fatigue. Concerned about his health, his parents took him to a doctor. Through the medical tests and screenings suggested by the doctor, little Dheena Dayal was diagnosed with Thalassemia Major. His treatment began at a private hospital but due to expensive medical treatments, his Bone Marrow Transplant was not done in that hospital.

On the advice of a doctor, he was then shifted to Aster Medcity, Kochi. Here, Dheena Dayal underwent a Bone Marrow Transplant. The estimated cost of his treatment was Rs. 17,00,000/-.

CHF helped the family raise funds for the treatment, and his surgery was performed successfully.

Dheena Dayal was discharged on 27th December.

EDUCATION SUPPORT







Child Help Foundation believes that every child in India has the right to create a bright future for themselves. Our team has been working towards helping these children achieve the best for themselves for the past decade.

1. Sakhare Ashram Shala, Palghar

Our volunteers paid a surprise visit to the Sakhare Ashram Shala, Palghar, on 6th December, to ensure smooth functioning of the Mini Science Centre (MSC) set up in the school. Our team interacted with the students to get feedback regarding the same.

Sakhare Ashram Shala a tribal school in Palghar that has 625 students is benefiting from the Mini Science centre set up by Child Help Foundation and funded by Samta Equal Footing Foundation. Our Volunteers also commemorated Dr. Baba Saheb Ambedkar and gave awareness to students about the importance of education

MENSTRUAL HYGIENE MANAGEMENT (MHM) PROGRAM









1. Dahisar, Mumbai

CHF volunteers conducted a sanitary pad distribution drive at Dahisar's Upadhyay Chawl to create awareness about Menstrual Hygiene. Sanitary Napkins were distributed among 200 young girls and women of menstruating age.

2. Dhenkanal, Odisha

On 22nd December, Child Help Foundation visited the Aluajharan Ashram School in Dhenkanal, Odisha. Under the Menstrual Hygiene Management (MHM) Program, we distributed sanitary napkins among 97 students and 7 local women from the village. The main purpose is to instill hygienic and safe practices during the menstrual cycle.

3. Bongaigaon, Assam

On 24th December, we reached out to more than 400 girls at the JNM Girls High School, Abhayapuri, Bongaigaon, Assam. To date, we have distributed sanitary napkins among 1,000 girls studying in

HUMANITARIAN RELIEF









To help individuals, all over the country, who have lost their jobs due to the pandemic, and have no means to support their families, Child Help Foundation has been working since the beginning of the pandemic to provide some relief to these individuals.

Unemployment has been on the rise and many families, with single breadwinners, are struggling to make ends meet. Our team has been working towards reaching out to as many families as possible. These families have expressed gratitude as CHF has been one of the first NGOs to support communities that are usually difficult to reach out to.

Our team has reached out to families living in Mumbai, Thane, Airoli Sector 19/20 (Maharashtra), Delhi, Odisha, Hyderabad (Andhra Pradesh), and Bengaluru (Karnataka). We have also reached out to families in Uttar Pradesh and Rajasthan.

In the month of December 2021, dry ration kits were provided to 427 beneficiaries. Apart from this, in collaboration with Roti Ghar, CHF provided cooked, nutritious meals to 1,800 individuals daily.

Tamil Nadu

- 1. Child Help Foundation volunteers visited the underprivileged community at Pulikkulam Village, Thiruvallur, Tamil Nadu. An initiative was undertaken to support 250 beneficiaries from the village who had suffered losses as rainwater had seeped into their homes. Ration Kits were distributed.
